 - Nicole -- can we find a stakeholder to represent each?
 - Tamra Brown (stakeholder) -- can connect to Girl's State representative from Hollywood High 2021 to model Int'l Youth Day
- b) Finalization of tee shirt design for purchasing pursuant to July General Board action.

- [Natalie -- shows Hollywood Heroes form, describes that this is a stakeholder-centered version of the stakeholder perspective sharing discussed in Item 5c. Reviews Instagram linktree.]
- Natalie -- can there be a fixed link for the meetings?
- Daniel Perez [CHNC] -- yes.
- Abramson -- size distribution + vendor. 50% L+XL, 40% S+M, 10% XXL+
 Jackie Vorhauer -- knows a vendor.
- c) Review of Google form for stakeholder social media amplification and discussion of policy. (15 min)
 - Nicole -- shows form; Q re: whether to ask about where in Hollywood stakeholder does their work, lives, etc.
 - Abramson -- asks stakeholders what characteristics they'd like to see in someone for us to amplify?
 - Nicole -- perhaps there should be two forms?
 - Tamra -- I like the opinion-driven aspects of this effort.
 - Natalie -- I like that this isn't self-nominating; not a showcase of a person but of their perspective of the neighborhood.
 - Louis -- how implement?
 - Yaru -- add to website, linktree, post in stories occasionally.
 - Louis -- what factors would we want to weigh, geography?
 - Nicole -- geography yes; nothing describing downtown.
 - Natalie -- we can start with trial and error until the volume is higher.
 - Louis -- one posting per quarter per participant.
 - Daniel -- add a note re: CHNC having editorial discretion.
- d) Discussion and possible action re: content for Congress of Neighborhood Councils ad. (5 min)
 - Daniel Perez -- planning committee has provided sponsorship tiers; CHNC's tier is "gold level," which includes a link on the website and ½ page ad.
 - Nicole -- will people get this in advance?
 - Perez -- should be distributed the week of the event.
 - Abramson -- I think we should showcase CHNC's accomplishments.
 - Nicole -- what we did, join us to learn how we did it.
 - Perez -- 1/4 page of 8.5"x11" paper. Due date is 8.24. PDF.
- e) Finalization of implementation of CHNC text engagement system. (10 min)
 - Nicole -- EZTexting; 120 free credits. People can text a number or follow a link to sign up. Haven't been able to connect to Hermon NC yet; would like to be able to do that before we press play. After the intro period, costs are \$19/mo.
