Daniel A Perez introduced the idea in the Del Rey NC last year, and we identified 7 high-visibility utility boxes and partnered with local non-profits/artists to purchase supplies and 4 have been painted thus far. Possible highly-visible CHNC utility boxes: NW corner Melrose/Vine, SW corner Santa Monica/Orange, SE corner, Santa Monica/Cahuenga, SW corner Vine/Sunset, etc...
